## AFFIDAVIT OF TRUTH NOTICE OF INFORMATION FILING OF CRIMINAL COMPLAINT

Dear Keith Cartwright,

My wife and myself were at the Lone Oak Community meeting months ago, the night that you attested you were on the mend from being deathly ill and recovered enough to be in the public again. In that meeting these topics were discussed:

- you discussing your illness and recovery with the help of your wife,
- Debbie Adams reporting on the trip from Washington discussing children's behavior problems at schools, including (but not isolated to) Sequatchie County,
- the sheriff reporting on state government installing Homeland Security in each county, and or creating an officer of Homeland Security in each county for the purpose of behavioral problems, and
- acknowledgment of the health problems and death of a community member.

An ongoing crime that is of the most serious nature has put us into a civil emergency, as defined in TN Code 38-9-101 (b). This was reported to the Sequatchie County Sheriff. It was **disregarded without due process** and consideration so it continues to happen to all residents. The sheriff was discovered to be acting **without an Official Oath of Office**, which is a Class C misdemeanor under TN Code 8-18-113.

The most vulnerable age groups have and are succumbing to radiation poisoning, emanating from new and upgraded Telecomm equipment. The **oxidative stress** from this equipment is prematurely killing the elderly. The young children are reportedly suffering from **behavior and learning problems which are some of the initial symptomology** of a much bigger problem occurring in their development stage including <u>endocrine disruption</u>, <u>cognitive impairment</u>, <u>mental health problems</u>, <u>delayed learning</u>, <u>and eventually disability and disease that can bee seen in the middle aged groups</u>, <u>which are turbo cancer</u>, stroke, and heart attack.

This lien against the sheriff serves as our diligence of process in exposing the most serious crime of our age, brought forward by victims and survivors initiating a Public Awareness Campaign that will only grow with intent and authority aligned with TRUTH.

Sheriff Bill Philips has showed the malfeasance of Duty and is <u>required to hand in his badge</u> immediately or Government of the County <u>will be required to terminate and replace.</u> He has had an opportunity to clarify his position and adequate grace. The crime was reported in mid-October and WE have lost nine months' time, that could have been utilize in identifying harms and has cost the general public in Sequatchie County valuable time in protecting themselves.

The goal of this awareness campaign is to assemble a lawful grand jury on the record to hear the evidence and to also interpret the regulatory laws that have left us all open to the **worst destruction of life and liberty** that America as a nation has ever witnessed, the cause of which is defined as **terrorism** by radiological means, TN Code 39-13-802 (a) and TN Code 39-13-803 (8) (c) radiological dispersal devices which are **legally defined as patented equivolent devices remsembling military equipment.** 

Now the government officials have been served with enough information for immediate inquiry and action as the clock is ticking and the harms and crime is building and escalating.

We are demanding that the Authority inferred upon you as an elected official be used in its fullest capacity to assist the Victims in bringing the evidence to lawfully Assembled Grand Jury.

By whatever means available and necessary; this will be conducted locally with the Authority Of The People and detractors will be liable and prosecuted as WE are all liable for our actions.

We look forward to hearing from you in a timely manner.

Return service is required and one week is given due to the seriousness and immediacy of this filing.

We, Benjamin Dylan Fowler and Perry Louis Fields, have personal knowledge of the above facts, are competent to testify to the above facts, and declare that the foregoing is true, correct and complete under the penalty of perjury.
