AFFIDAVIT OF TRUTH NOTICE OF INFORMATION FILING OF CRIMINAL COMPLAINT

Dear Sarai Pierce and School Board,

We are writing to inform the public school system that a disastrous crime is being committed to all the children and employees of the school system. This crime is Public Endangerment, Crimes Against Life and Failure to Ensure Safety of the Telecomms Equipment (cell towers) that hover directly over Sequatchie County schools. **See Tennessee Code 39-13-802, 806; Terrorism with Use of Radiological Weapons.** The deployment of radiological equipment without proven safety data, disclosure of dangers and the five year health epidemic that has and is transpiring, are a direct attack on the people of America and violations of The Geneva and Hague Conventions against the health of mankind.

Our full intention is in pursuit of remedy of this crime and a prohibition into this infrastructure. In tracking the reported health of the country it has been observed that **mental health and behavior performance has been diminished in the children.** When coupled with turbo cancer, stroke, heart attacks, massive fertility decline, and the myriad of disease that leads to the previous stated outcomes, **all points to Acute Radiation Syndrome, which the mechanism of action is easily provable as oxidative stress.** Mountains of cases and studies are being willfully obfuscated and victims have not been heard in court.

We are aware of policy that has fast tracked and enabled the installation of this equipment while fraudulently obfuscating research and debate of the scientific community hindering informed consent and choice. We also have many accounts of health decline, sickness and instability occurring in the community and brought to us directly. This leaves the county school system in a precarious position as your corporate structure is beholden by policy of local, state and federal government; however, we believe you are victims as well, and entirely unaware and subjected to the same radiation.

The Dunlap towers by the schools are hurting the children and are being used as an excuse for more federal government intervention, and yet not a single discussion or debate can be made about this microwave radio frequency publicly. **Mental health challenges are the first sign of harm, with**

resulting cognitive issues, learning disorders, sometimes resulting in the abuse of various drugs and/or coping mechanisms, or explained away as just “bad behavior.”

The safety has **never been proven** of this pulsed radio frequency which has had several evolutions increasing in POWER levels and CAPABILITIES. The action required is to preserve health, safety and security by any means necessary and that will begin and end with the parents, if the authority of the school system is unable to see their obligation with clarity.

We are seeking cooperation with the school to slow, prevent and stop continued harms. We have included documentation of our efforts thus far, along with a few, select studies to support our claim.
